- III. Administrative budget approved 4/16/22
- IV. Services
 - a. Recycling: CM suggests, after meeting with Recycling Committee, to maintain flat
 - b. Motion to approve Services with the above by Gormady, second by Williams, unanimous vote in-favor
- V. Economic Development
 - a. Chamber of Commerce
 - i. Advertising
 - ii. Public bathroom maintenance
 - Originally maintained by COC, now maintained by Rosie's hot dog stand with payment by City as per previous City Manager Devonshire
 - a. Gormady asks: is their staff covered by commercial cleaning insurance
 - b. Alternatively, is Rosie's staff "employed" by Port Authority to clean and maintain bathrooms?
 - b. Motion to approve \$3300, unanimously approved
- VI. Expense (Reserve Capital), passed last meeting
 - a. (Reserve Capital Infrastructure) \$92K approved unanimously (Gormady, Williams, unanimous in-favor vote)

Risk Management specifically is at 90% thus far this fiscal year Increase by 10% (\$46750 last fiscal year) to \$51425)

- XI. Open Forum
 - a. Bailey: research re costs per student for education at Eastport Schools
 - i. Shead tuition students cost per student: ~\$13K
 - 1. N= 52 tuition students currently
 - 2. = ~\$691 K
 - 3. Local students N=31
 - 4. Total high school budget based on these costs = ~\$1.1 million
 - ii. Elementary school: current is 2 tuition students; cost ~9K
 - 1. N=83 local students + 2 tuition + 3 non-classified
 - 2. Total elementary cost: ~\$824K
 - iii. Total with elementary and high school combined: \$1.9 million

- iv. Eastport taxpayers' fair portion: \$1.1 million
 - 1. To exceed this per Bailey means City residents could be subsidizing out-of-City students to be educated
