There was a dispute with the property owners and resulted with the sewer line being cut on 10/16/2018 and there is language in our Sewer Ordinance that does not permit us to bill if they are not hooked into the drain system or Sewer system and we do not have the authority to commit this Sewer charge against that dwelling and the City Manager states that he pro-rated it back to the date that the house became disconnected from the Sewer system.

The City Manager informs that the City is providing bags and gloves and he will be helping and assisting with picking up the bags as they are filled with his truck and dropping off new supplies as they are needed. There will be a sign up sheet at City Hall to assign people

in teams. This wraps up nicely with the sweeping of the streets to help with the cleanup of the community. He also updates that on May 15 the Public Works crew is going to go around and pick up sand that has been deposited in people's yards if they rake the pile to the edge of the street and he asks that it not be directly into the street as it defeats the purpose of the street sweeping just completed. Councilor Peacock asks the City Manager if he had contacted the Coast Guard to see if they are going to maintain the County Road section and he responded that he has spoken with Chief Smith and he going to bring his crew and they will be participating in the clean up day.
